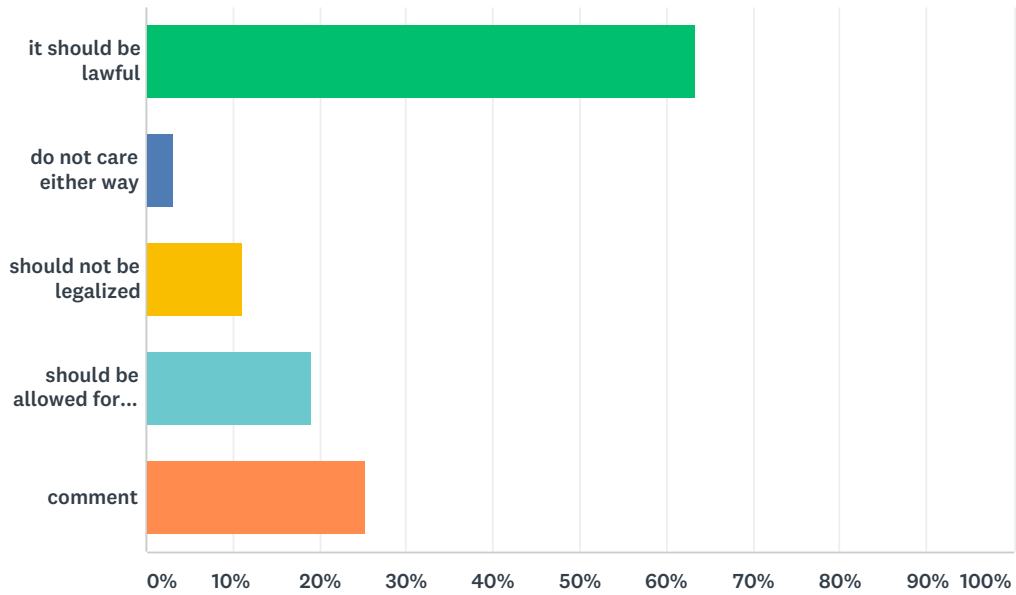


## Q1 How do you feel about cannabis use?

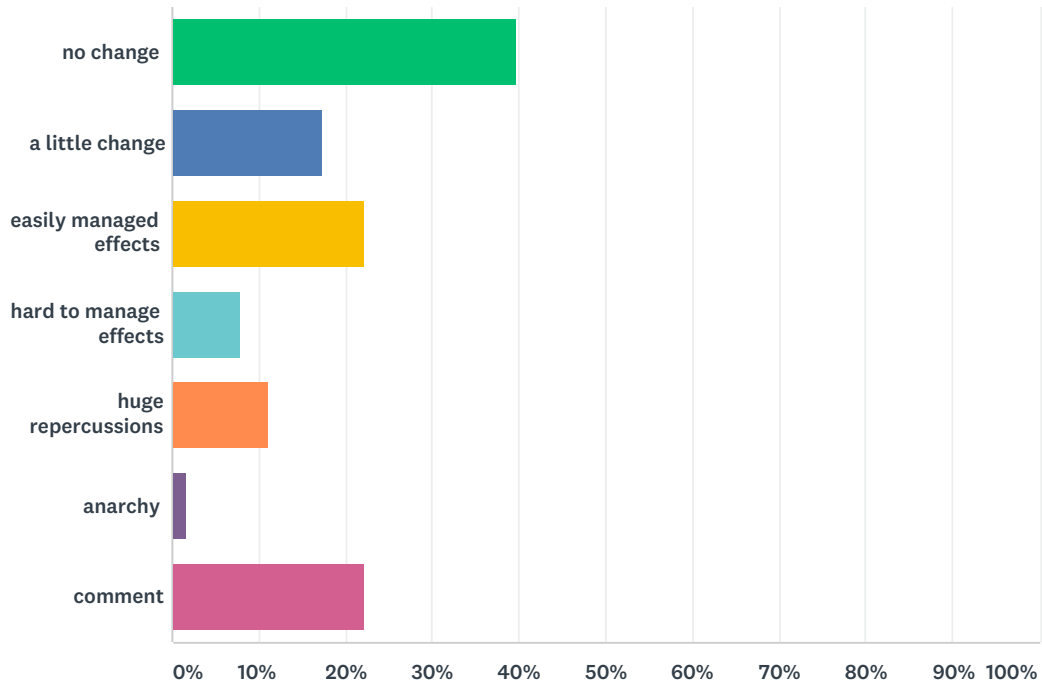

## Q2 What effects do you think the legalization of recreational cannabis will have on society?

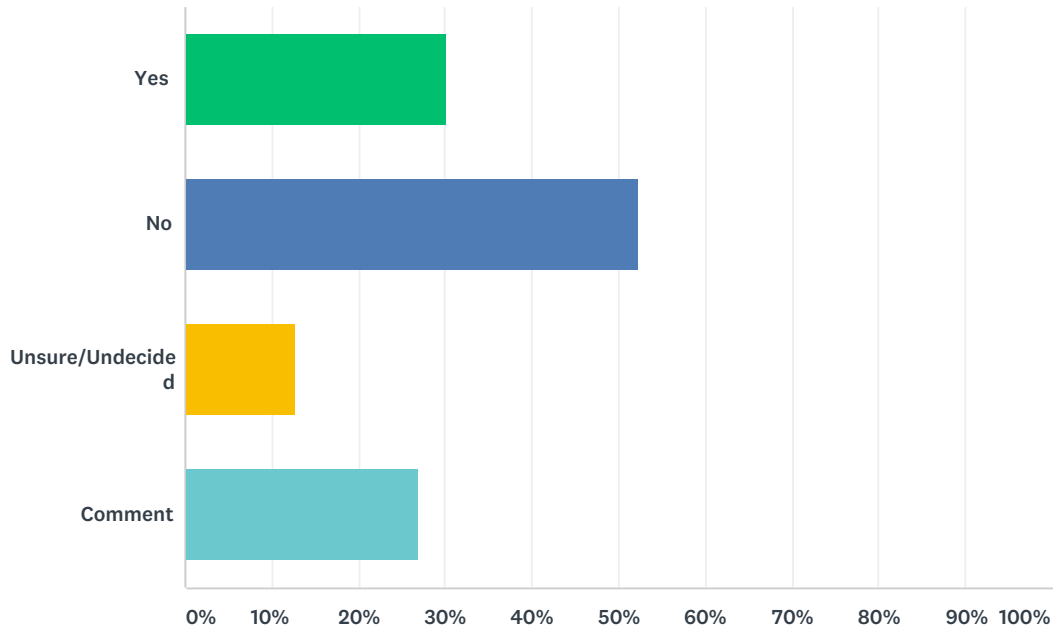

### Q3 Do you think the legalization of recreational cannabis will have an effect on road safety?

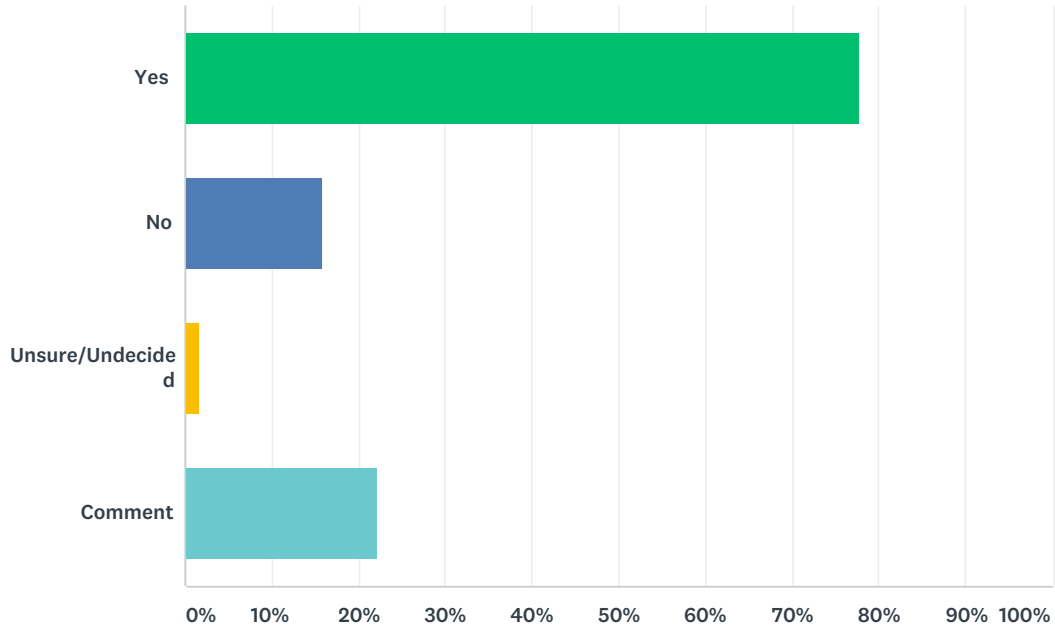

### Q4 Should medical cannabis dispensaries be permitted on WFN Lands?

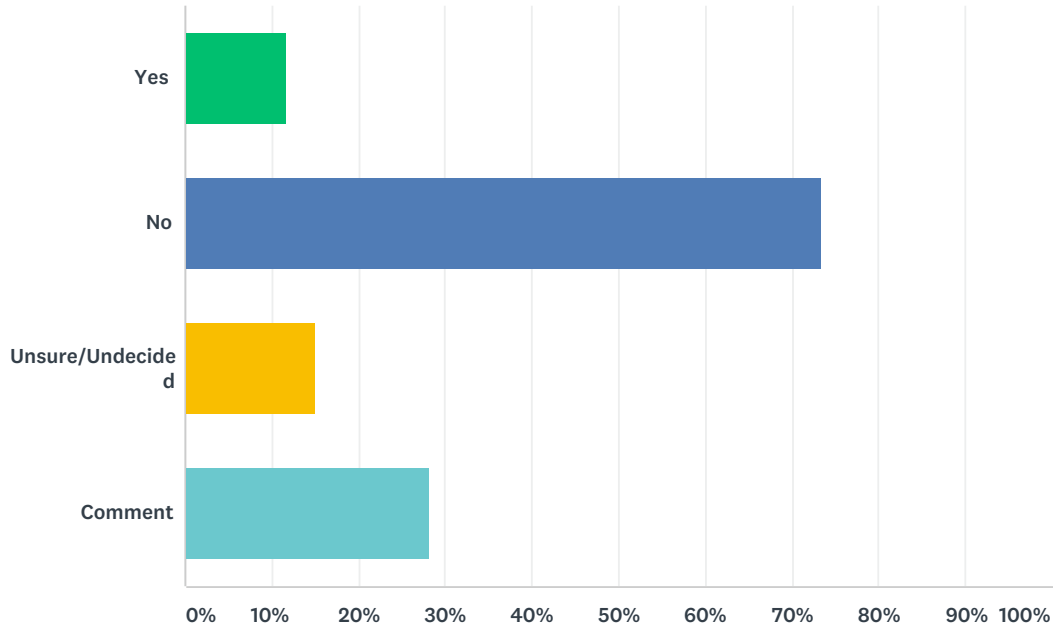

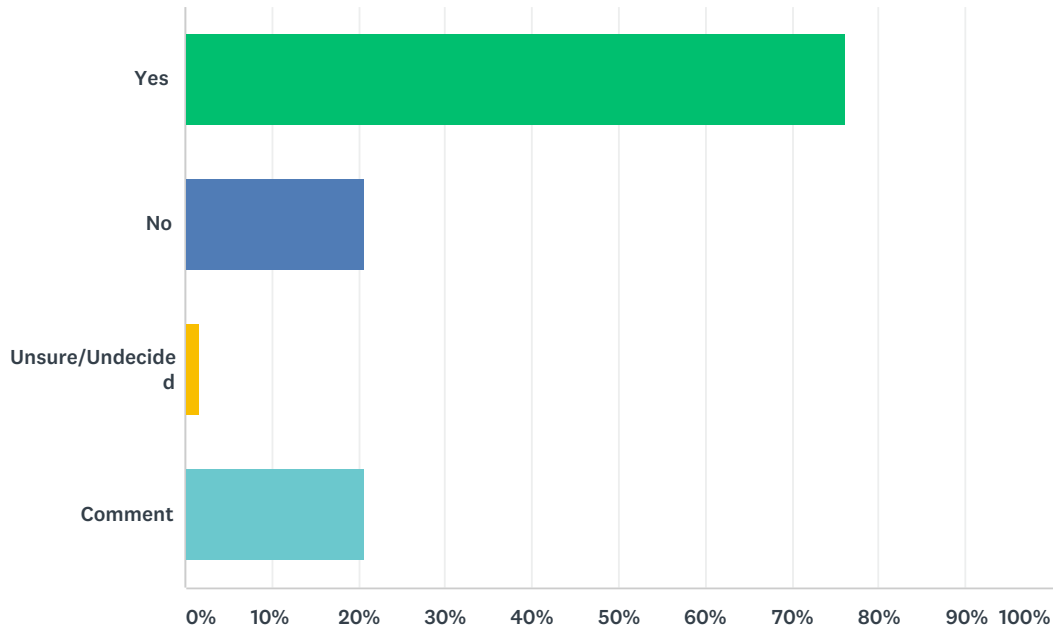

## Q6 Should recreational cannabis retail stores be permitted on WFN Lands?

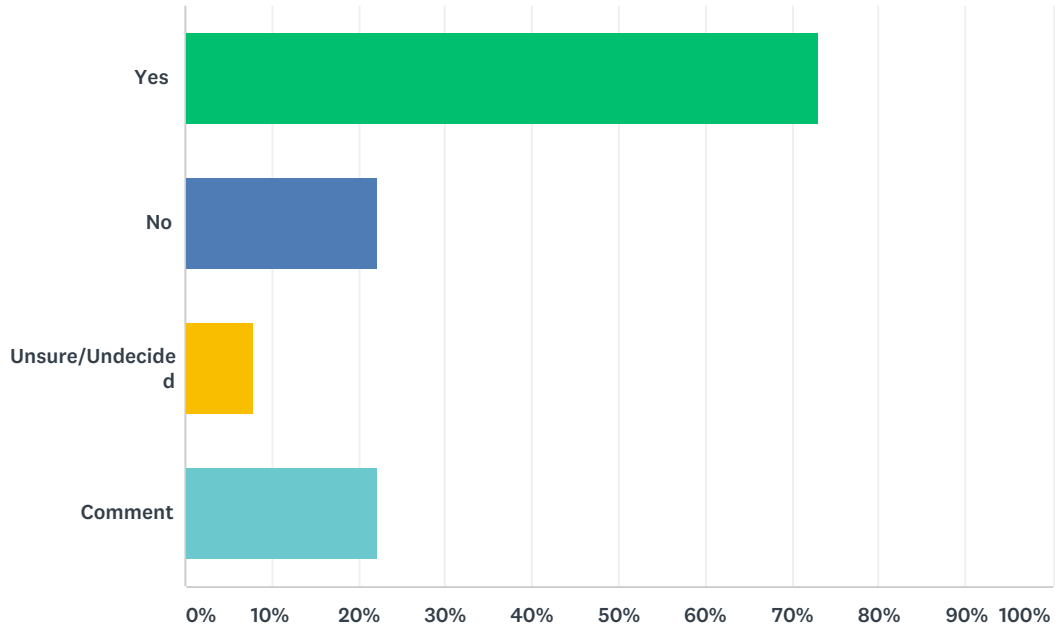

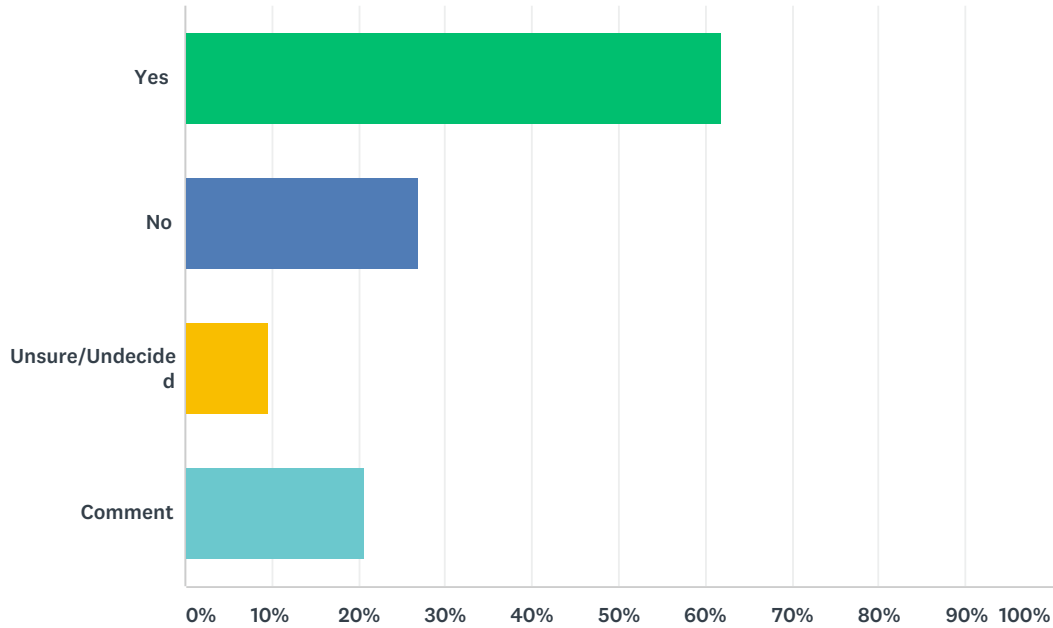

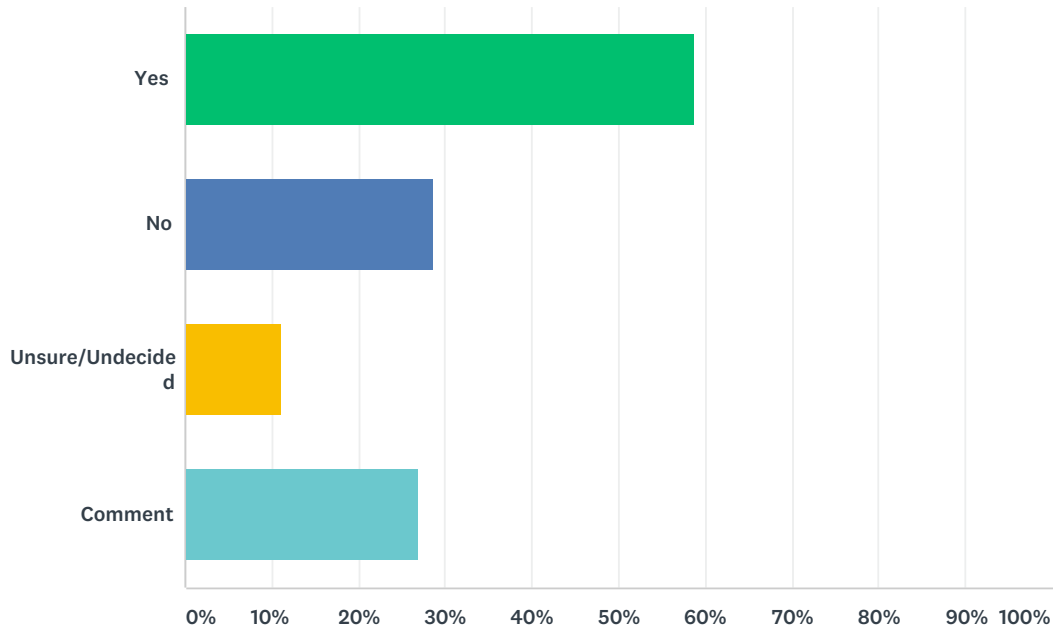

### Q9 Do you think private businesses that are involved in the sale of cannabis should be required to have additional security in place?

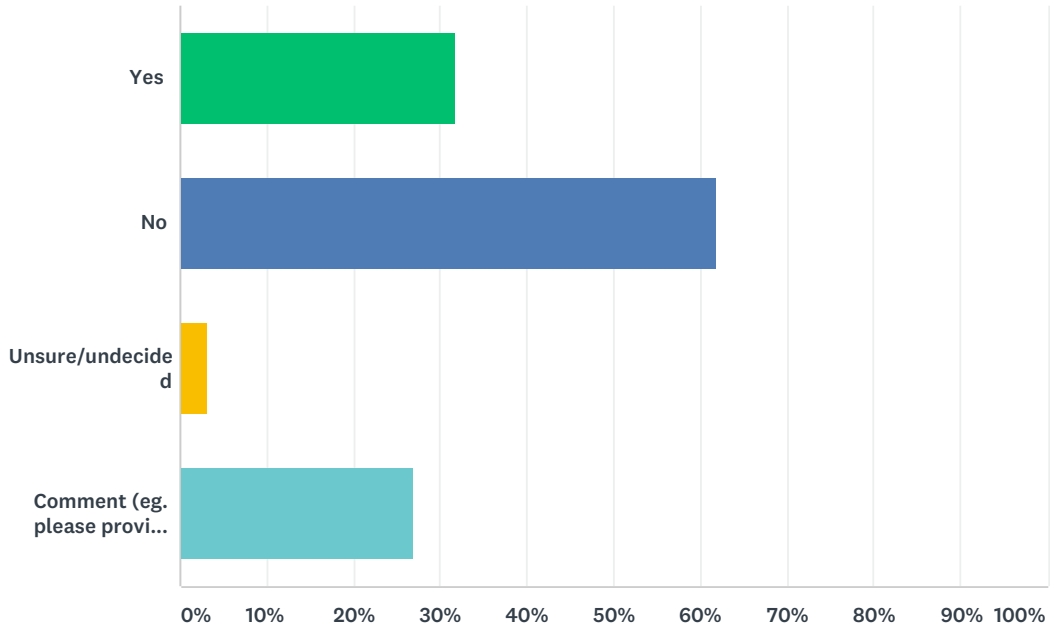

# Q10 Do you think that private businesses that are involved in the sale of cannabis should be required to pay a higher fee for their business license?

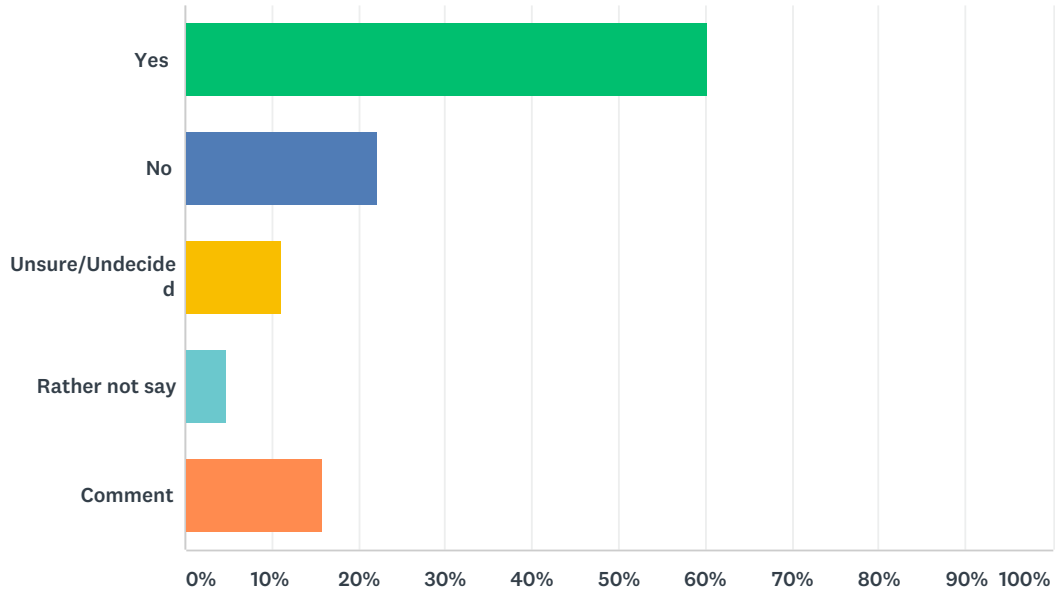

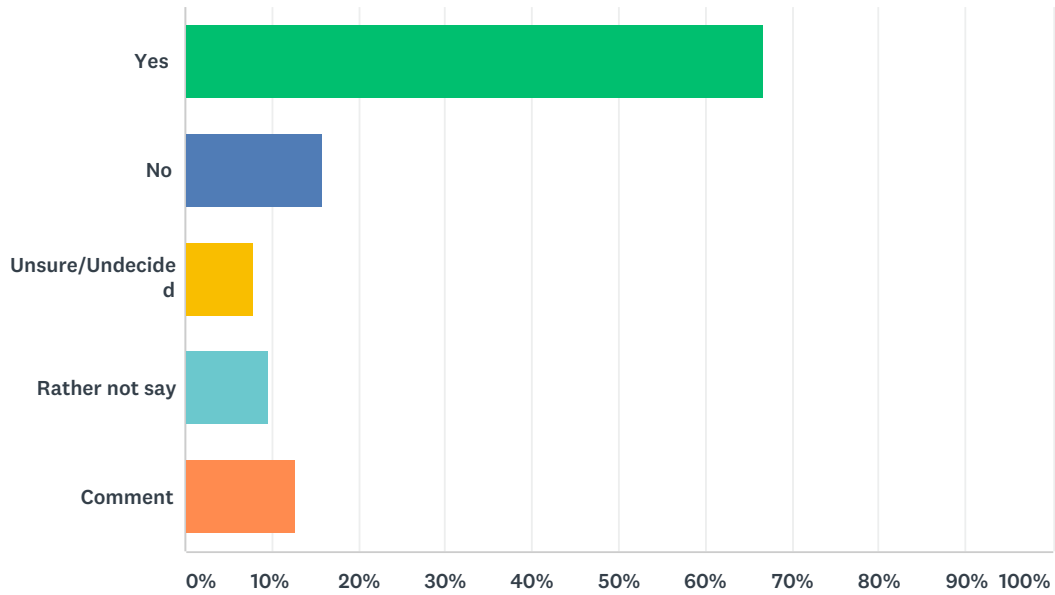

## Q12 Do you have friends or family who currently use recreational cannabis?

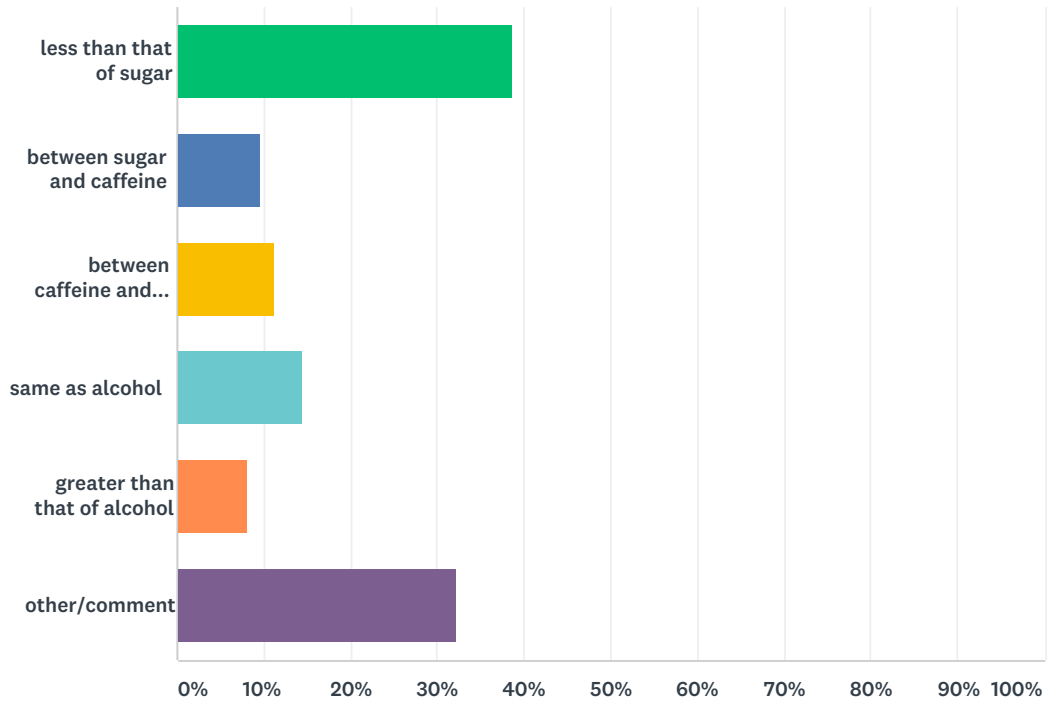

### Q13 Where would you place cannabis in terms of its negative health effects on the human body?

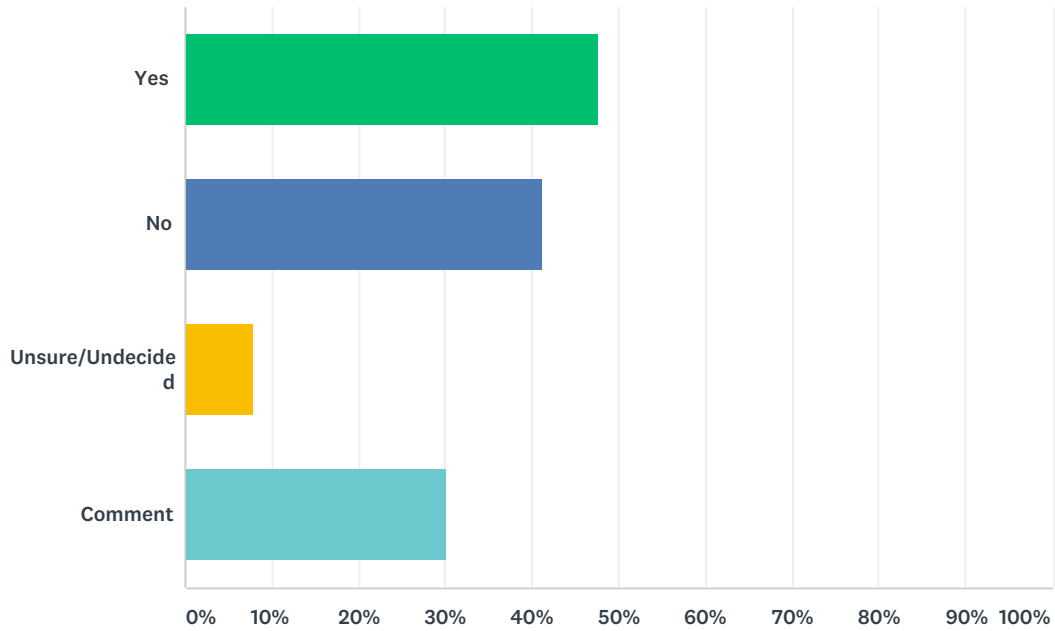

### Q14 Do you have a view regarding whether smoking cannabis is equivalent to smoking tobacco?

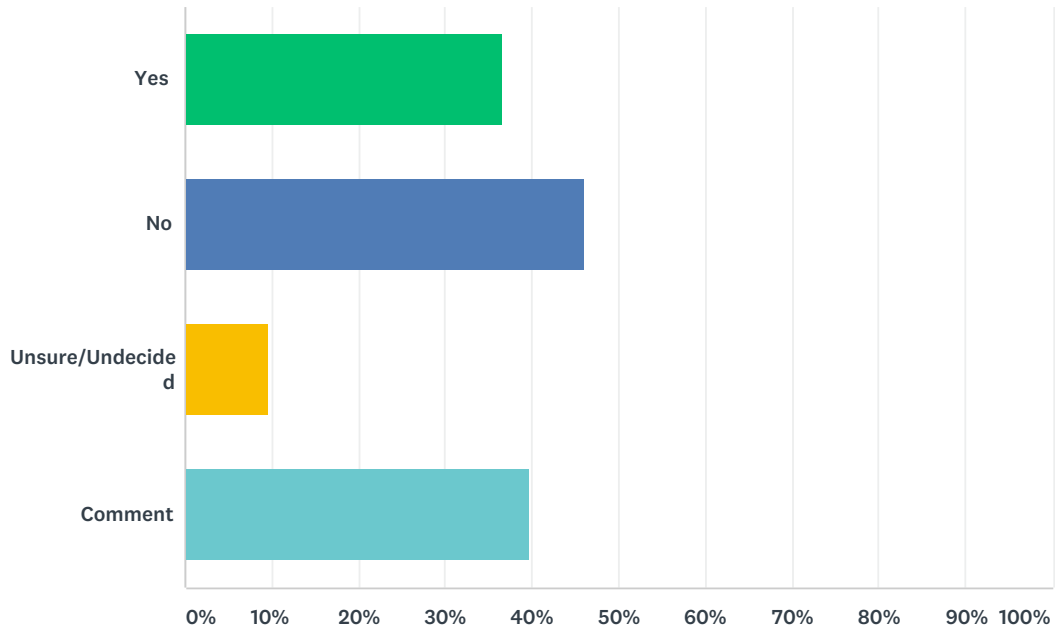

### Q15 Do you have a view regarding whether cannabis use is equivalent to drinking alcohol?

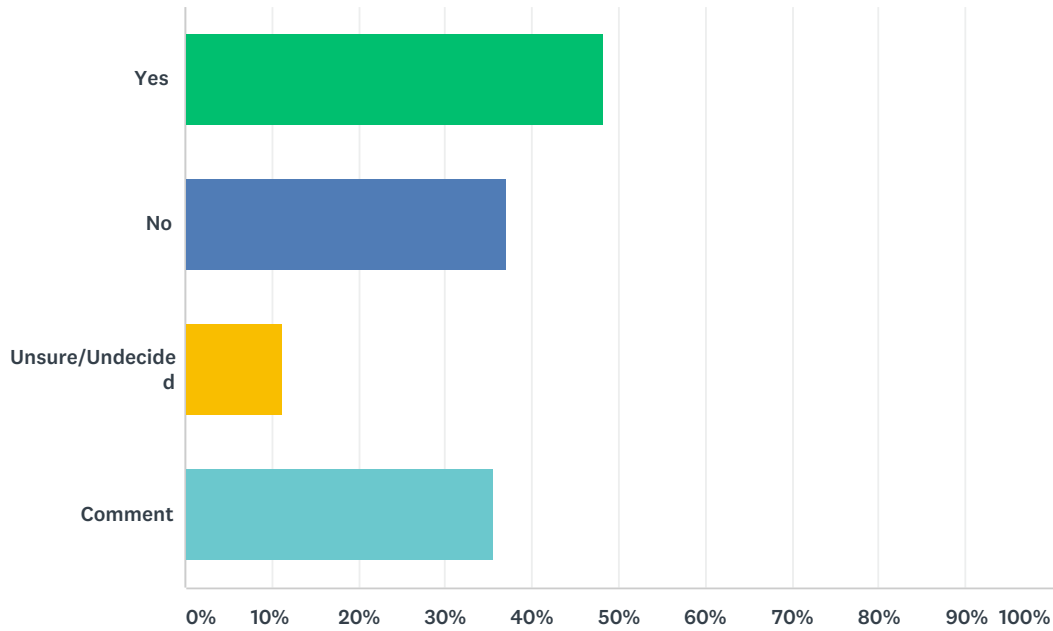

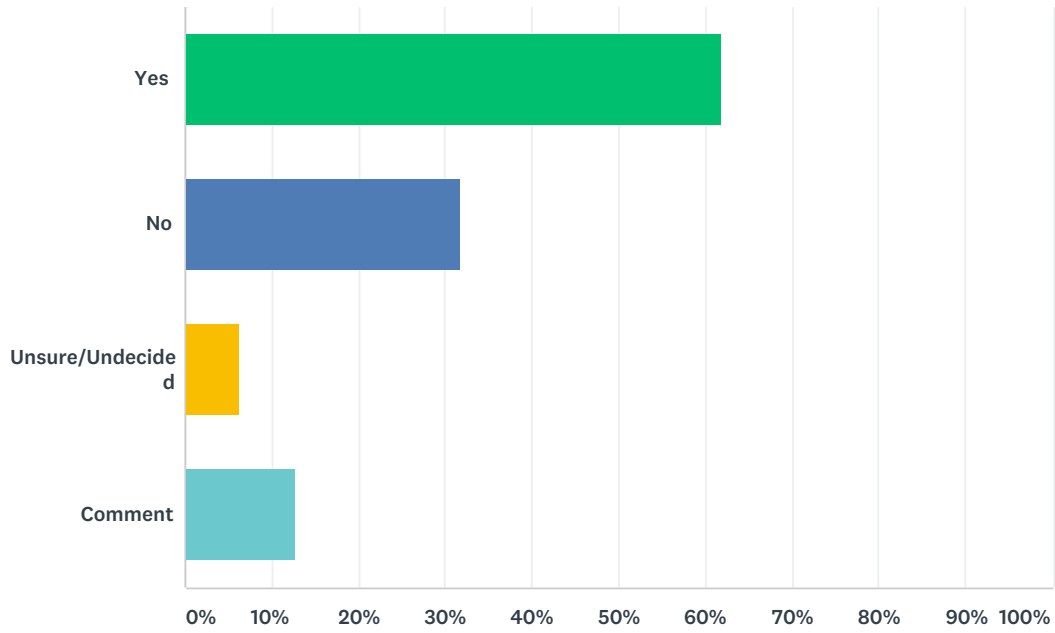

## Q17 Are you in favour of cannabis lounges being permitted to operate on WFN Lands?

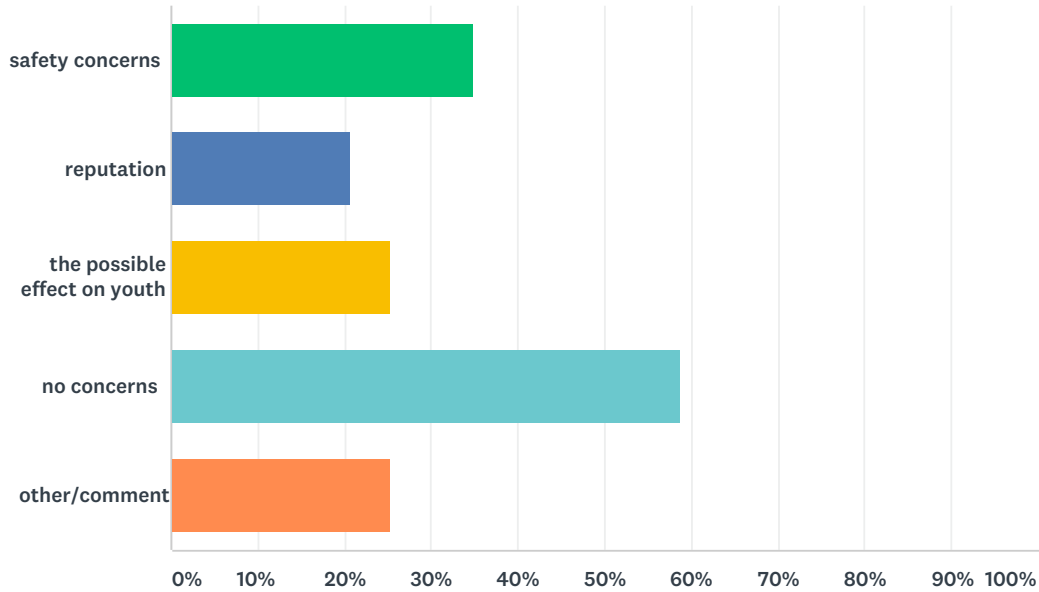

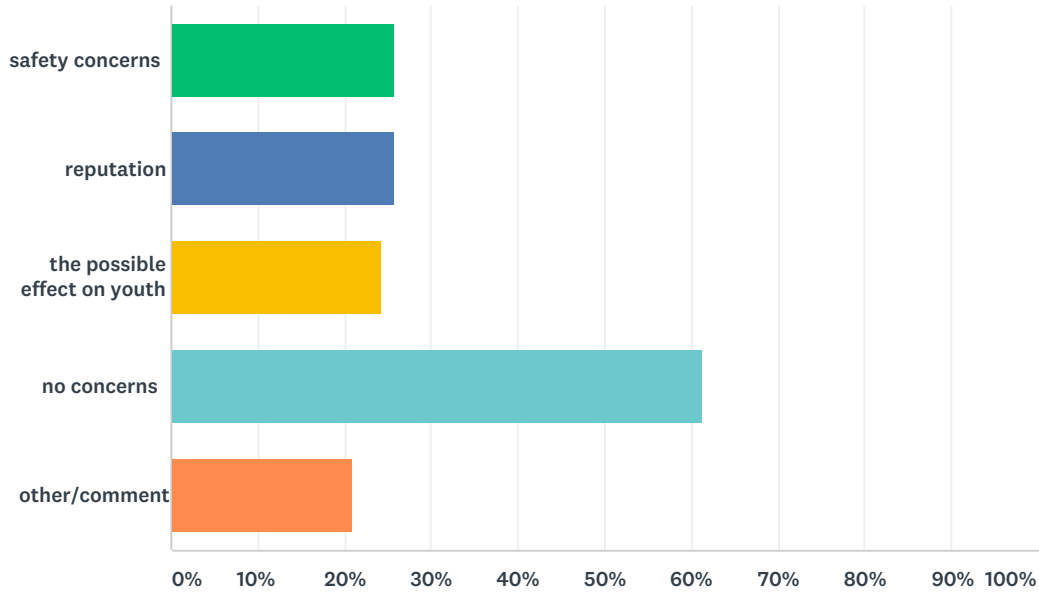

## Q19 What are your views on changing WFN’s Law to permit the cultivation and sale of recreational cannabis and recreational cannabis products on WFN Lands?

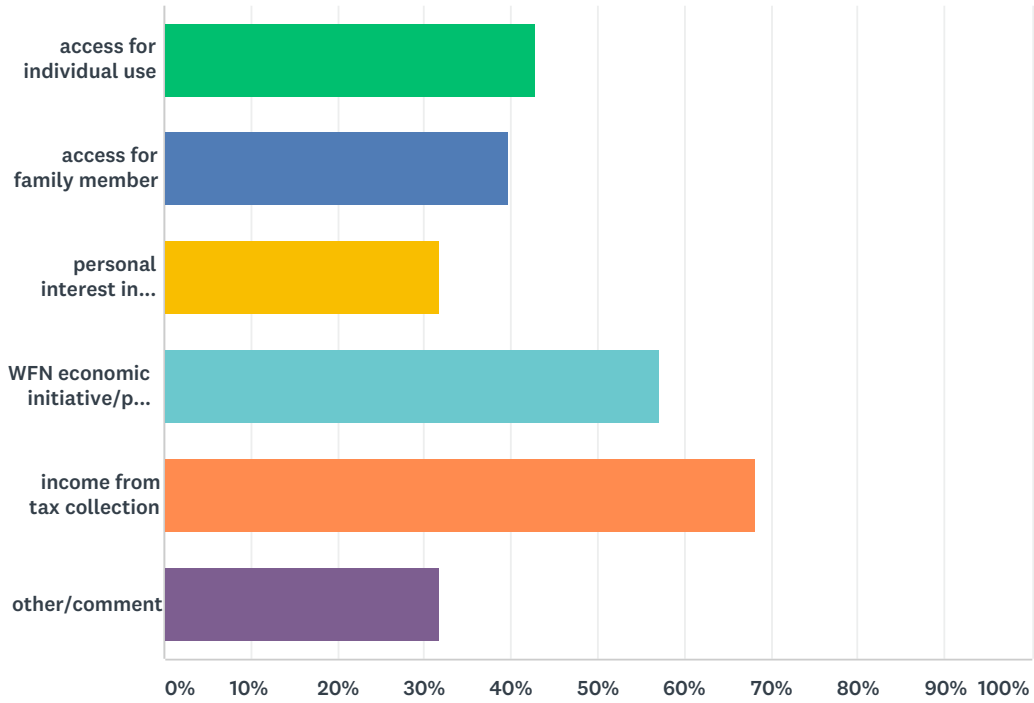

Q20 What do you view will be positive outcomes from changing WFN Law to permit cultivation and sale of cannabis on WFN Lands? Check all that apply.

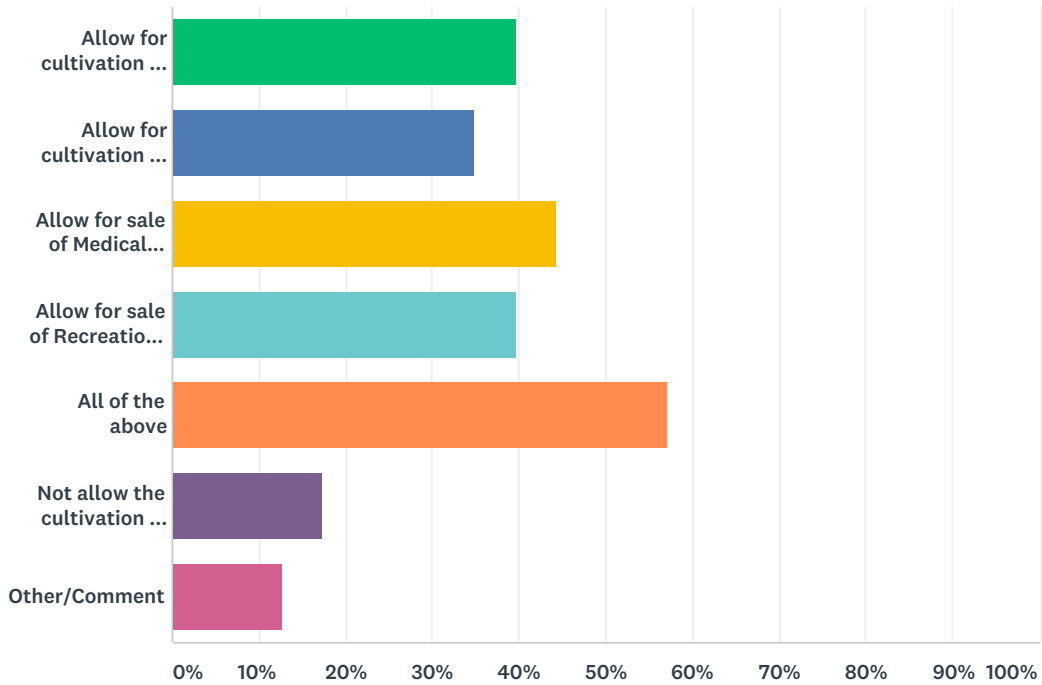

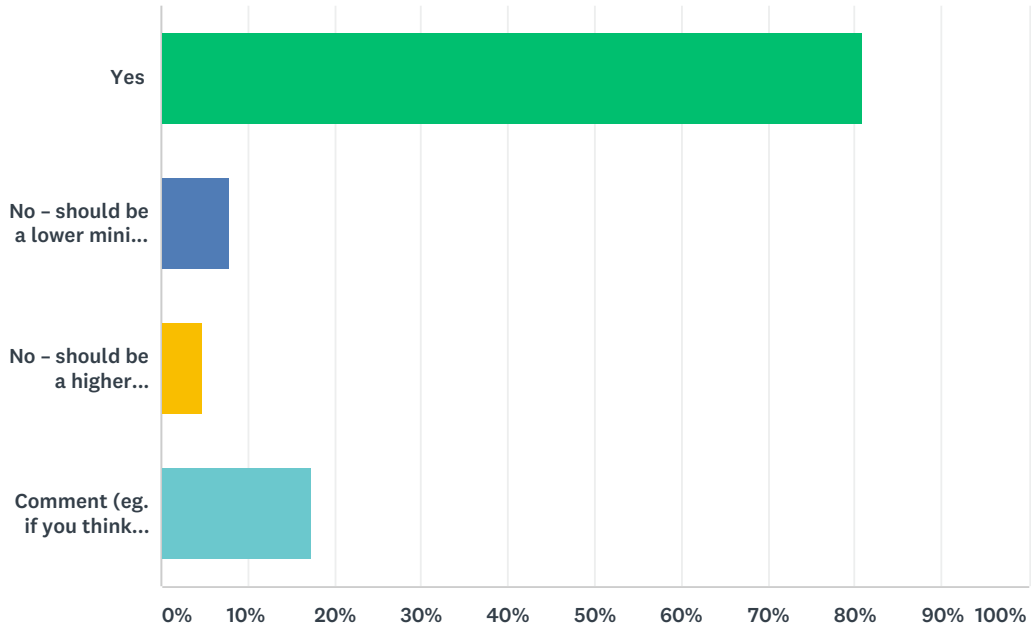

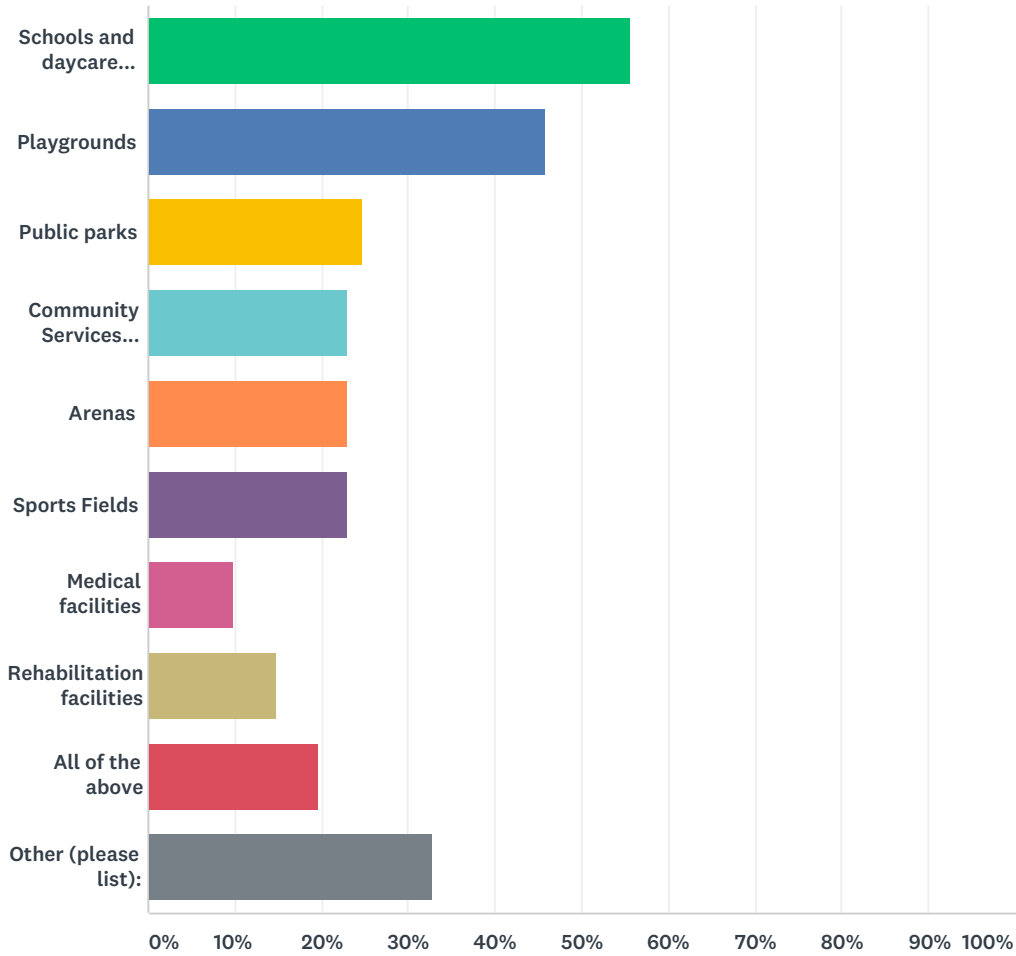

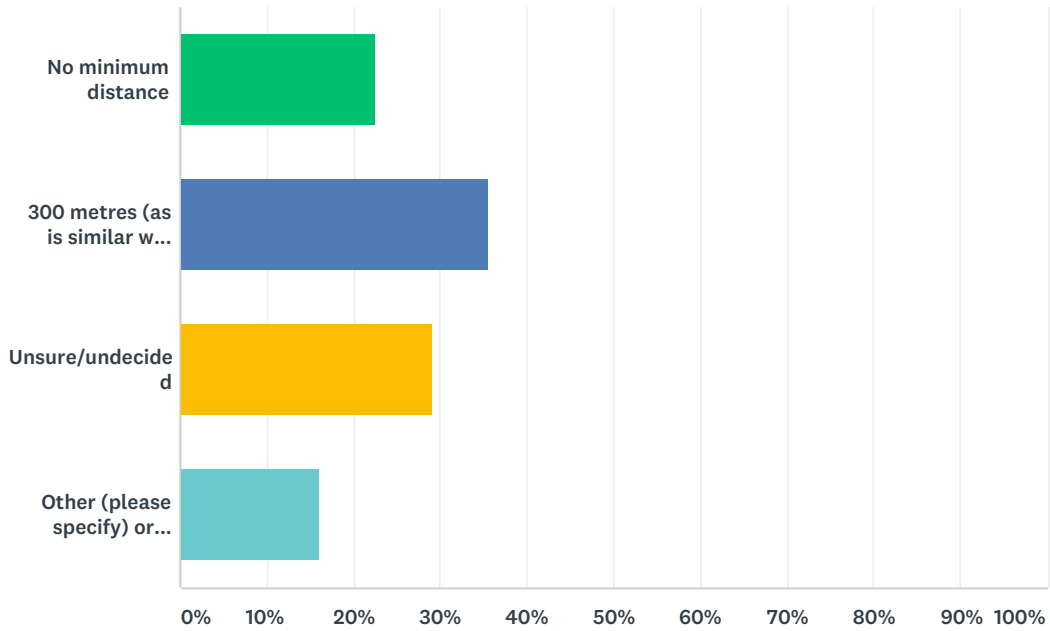
