Rules and Regulations

1. One camp site per Member, for a maximum of 7 consecutive days.
2. One recreational vehicle and one tent permitted per lot.
3. There is to be no subletting of the campsite.
4. No makeshift lodging of any kind, only listed accommodation types are permitted.
5. The Registered member is responsible for all damages including damages caused by guests.
6. ATV use is restricted to road use only.
7. Firewood collection is to be done offsite and no wood can be left behind due to mowing.
8. All garbage/recycling to be packed and removed from the campsite upon departure. Do not leave in firepit as it will attract bears.

QUIET HOURS

Quiet hours are from 11:00pm to 6:00am. Generators to be off at 9:30pm to respect other campers and neighbours.

GUESTS

Maximum site occupancy is 8 people.

PARKING

All vehicles and accommodation are to be kept within the boundaries of each campsite so as to not impair the flow of traffic.

PETS

Pets must be kept on a leash and must not be allowed to roam free. Pet waste shall be bagged and disposed of appropriately. There is a local, large but very friendly, black and white dog that pushes bears out of the area. Please do not feed him.

OUTHOUSE is available on site. Please keep clean and be advised that toilet paper is not provided.

SAFETY

1. Unauthorized use of fireworks is strictly prohibited.
2. The Registered member shall abide by all burning regulations including campfire bans.
3. The speed limit within the campsite area is 10km.
