SUBJECT: **WFN N7 Challenge**

Purpose of this Policy

To establish a program called the "WFN N7 Challenge".

Statement of Policy

The Nike N7 Program

The Nike N7 Program is an initiative of Nike, created through inspiration of the Seven Generations philosophy which recognizes that the decisions made today will impact the 7th generation. The intention of the program is to inspire and enable participation in sport by Aboriginal people, believing that this will lead to a healthier lifestyle, greater self-confidence and more responsible decision making which, in turn, will help build a healthier community. Through the Nike N7 Program, Aboriginal communities not only have access to specific discounted Nike products, but are also able to access donations and grants for the support of sports and physical activity programs for youth through the N7 Fund. About 30% of the profits from the sale of N7 products go into this fund which is used purely for the promotion of health and wellness in aboriginal communities.

The WFN WFN N7 Challenge

In response to Nike's recommendation that the specific discounted products be used as incentives to encourage community members to be active, the Westbank First Nation ("WFN") Recreation Department has created the WFN N7 Challenge, a program that enables WFN Members to earn rewards of certain Nike products by participating in qualifying WFN recreational activities.

Details and Outcomes of Policy

Qualifying WFN Recreation Activities

The recreation activities included in the WFN N7 Challenge will be identified by the WFN Recreation Department from time-to-time. In general, these will include the use of WFN recreation facilities, such as the gymnasium and weight room, and participation in WFN recreation programs with a physical activity component, such as drop-in sports programs.

Qualifying WFN N7 Challenge Rewards

The products available as WFN N7 Challenge Rewards are subject to the seasonal offerings of Nike and the budget established by Council. They will be subject to change from time-to-time.

Participation Requirements

In order to earn a WFN N7 Challenge Reward a WFN Member must:

1. register with the WFN N7 Challenge through the WFN Recreation Department;
2. participate in a qualifying WFN Recreation Activity ten times for a minimum of one hour each time;

3. record their participation in each WFN Recreation Activity in the N7 register and have it signed off by the WFN Recreation Department;
4. upon completing the WFN N7 Challenge, order their WFN N7 Challenge Reward through the Recreation Department; and
5. upon receiving their WFN N7 Challenge Reward:
 - a. confirm with the Recreation Department that they are satisfied with the reward; and
 - b. sign the reward register.

Eligibility

The WFN N7 Challenge is open to registered WFN Members only.

In order to qualify to receive a WFN N7 Challenge Reward, a Member must complete the WFN N7 Challenge within six months of registration.

A Member may register for the WFN N7 Challenge no more than once every six months.

Establishment of a Budget

Council will, as part of the annual budgeting process, seek to set aside funds in order to ensure the commitment of this policy on a best efforts basis.
